2017 POV Mail-In/Online Base Rebate Consumer Official Terms and Conditions: This consumer mailin or online rebate offer is valid in connection with a qualifying end-user patient ("Patient") purchase of a pair of prescription eyeglass lenses under a current valid prescription ("Lens Purchase") with one or more products (each an "Eligible Product") from one of the following three groups of products (each a "Group"): Group 1: Varilux*, Crizal* and/or Essilor* Transitions*, Group 2: Eyezen+™, Crizal* and/or Essilor* Transitions*, OR Group 3: Xperio UV™, Varilux* or Eyezen+™. Each Lens Purchase with an Eligible Product shall be referred to as a "Qualifying Lens Purchase." Each Qualifying Lens Purchase must occur between April 1, 2017 and September 30, 2017 (the "Purchase Period"), exclusively through a participating independent eyecare practice authorized by Essilor for this rebate offer (each an "Authorized Practice") and listed on www. powerofvision.com (the "Promotion Website").
